IN ALL, OASIS HAS CARED FOR 619 ANIMALS - MANY OF THEM VERY ILL WHEN THEY WERE SURRENDERED TO OASIS. AT THE END OF 2018, 17 WERE STILL WITH US, 9 OF WHICH ARE "PERMANENT RESIDENTS" AS THEY HAVE BEEN TOO TRAUMATIZED OR ARE TOO DISABLED TO BE ADOPTED OUT. ANIMALS INCLUDED: DOGS, CATS, HORSES (FROM DRAFTS TO PONIES), DONKEYS, DUCKS, GUINEA PIGS, SNAKES, HAMSTERS, A DOMESTIC TURKEY, FERRETS, A ROOSTER, AND GOATS AMONG OTHERS. THE PROGRAM PROVIDES HEALTHY NUTRITION, EXCELLENT VET CARE, AND SOCIALIZATION WITH OTHERS OF THEIR SPECIES AS WELL AS WITH HUMANS.
