FROM THE PROGRAM'S INCEPTION IN 2002 UNTIL 12/31/20, 7,163 ANIMALS WERE SPAYED OR NEUTERED, EFFECTIVELY AND HUMANELY PREVENTING THE BIRTHS OF TENS OF THOUSANDS OF HOMELESS OR UNWANTED ANIMALS. THIS PROGRAM HAS 9 PARTICIPATING VET HOSPITALS AND CLINICS, AND OASIS PAYS THE ACTUAL (REDUCED COST) SURGERY INVOICES.
