STERILIZATION ASSISTANCE PROGRAM: THIS PROGRAM IS RUN TO HUMANELY REDUCE UNWANTED ANIMAL POPULATIONS THROUGH SPAY AND NEUTER SURGERIES. 241 ANIMALS PARTICIPATED IN THE PROGRAM IN 2016, MOST OF WHICH WERE STERILIZED BEFORE YEAR END. FROM THE PROGRAM'S INCEPTION IN 2002 UNTIL 12/31/16, 6,212 ANIMALS WERE SPAYED OR NEUTERED, EFFECTIVELY AND HUMANELY PREVENTING THE BIRTHS OF TENS OF THOUSANDS OF HOMELESS OR UNWANTED ANIMALS. THIS PROGRAM HAS 9 PARTICIPATING VET HOSPITALS AND CLINICS, AND PAYS THEIR ACTUAL (REDUCED COST) SURGERY INVOICES. REVENUE TOTALS \$15,295 AND CONSISTS OF \$7,055 IN GRANTS AND INDIVIDUAL CONTRIBUTIONS, AND \$8,240 OF CO-PAY FEES. EXPENSES TOTALED \$25,328 OF WHICH \$17,744 REPRESENTS PAYMENTS TO OUR PARTICIPATING VET HOSPITALS PERFORMING THE ACTUAL SURGERIES, AND \$384 FOR PRINTING OF FORMS AND REFUNDS OF CO-PAYS. THE BALANCE OF \$7,200 REPRESENTS INDIRECT PAYROLL EXPENSE OF THE PROGRAM.
